# ECONOMIC DEVELOPMENT SUMMIT

For two half days in mid-2023, key stakeholders in the economic development arena of Dunn County convened the first Dunn County Economic Development Summit. The group included representatives from the Dunn County Economic Development Corporation, the Greater Menomonie Development Corporation. the City of Menomonie, Dunn County, CVTC, UW Stout, Workforce Development, the Greater Menomonie Chamber of Commerce, Downtown Menomonie. Momentum West, and the Wisconsin Economic Development Corporation. The focus of the summit was to assess the community's strengths, opportunities, gaps, and duplication of effort in the area of local economic development and to evaluate interest in, and planning for, system enhancements.

The two-day event was filled with a lot of discussion and planning and evolved into an ongoing group which has been meeting quarterly to carry on the priorities for action identified at the summit. Three workgroups were formed: Business Retention & Expansion, Workforce Housing, and Small Business Development and Entrepreneurship. Those workgroups met regularly over the summer and fall, refining the planning completed in the spring. The whole stakeholder group will reconvene in March 2024 and consider a second annual summit.
